ORDER:

In the reference 1st read above, the Telangana Admission and Fee Regulatory Committee (for Professional Courses offered in Private Un-Aided Professional Institutions) Rules, 2006 have been issued and under Rule 4(iii) of the said Rules, the TAFRC is at liberty to approve or alter the proposed fee for each course to be charged by the Institution.

2. In the reference 2nd read above, the AO, TAFRC has furnished the Minutes of the TAFRC Meeting held 18.06.2025 wherein the following recommendations have been made: -

- a) The proposals made by the Private Unaided Professional Colleges for the block period of 2025-28 are at variance with the parameters, terms and conditions of the relevant orders of the Supreme Court and High Court.
- b) Government may appoint a Committee of Officers to examine the parameters for fee fixation and suggest revised parameters for fee fixation in respect of Private Unaided Professional Colleges, duly studying the process being followed in other States and keeping in view the relevant Supreme Court and High Court orders.
- c) Till then, the fees fixed earlier for the block period of 2022-25 may continue to be applicable.

3. Government after careful examination of the matter, hereby decided to issue the following notification which shall be published in the Telangana Gazette:

In exercise of the powers conferred under sub-rule(v) of Rule 4 of the Telangana Admission and Fee Regulatory Committee (for Professional Courses offered in Private Un-Aided Professional Institutions) Rules, 2006 issued in the G.O.1st read above and in pursuance of the recommendations of the TAFRC, vide reference 2nd read above, the Governor of Telangana hereby notify the recommendations of TAFRC to continue the Fee structure fixed for B.E./B.Tech, M.E./M.Tech, B.Arch., M.Arch, B.Pharmacy, M.Pharmacy, Pharm.D&Pharm.D(PB), MBA, MCA, MBA Integrated, B.Vocational Courses offered in Private Un-aided Professional Institutions in the Telangana State for the block period 2022-2025 be continued for the Academic Year 2025-26.
